Approval will be based on aesthetic appearance only. No approval shall be construed as approval of structural integrity nor the quality or durability of the material considered.

IMPORTANT:

NO APPROVAL WILL BE GIVEN FOR ASPHALT SHINGLE ROOFING.

NO APPROVAL WILL BE GIVEN FOR MATERIALS IMITATING SLATE OR CLAY TILE. NO APPROVAL MAY BE GIVEN FOR INSTALLATION OF ALTERNATE ROOFING MATERIALS WITHIN A DISTRICT WHEREIN A BURNED CLAY TILE OR SLATE ROOF IS MANDATORY.

ALL MATERIALS SIMULATING WOOD ROOF MUST BE FLAT.

ANY DETACHED STRUCTURE TO BE RE-ROOFED TO MATCH RESIDENCE AT THE TIME OF RE-ROOF.

PAINT OUT VENTS & FLASHING TO MATCH ROOFING MATERIAL. EDGE METAL TO MATCH FASCIA COLOR OR SUBMIT COLOR FOR APPROVAL. RAKE END TILES ARE NOT PERMITTED.

ALL MATERIALS TO BE INSTALLED MUST HAVE ART JURY APPROVAL.

To ensure that the resulting construction meets the criteria above established, the following items shall accompany each application and submission if requested to do so:

- Photographs of existing roofing from all sides of the property and as viewed from the street/s.
- Manufacturer's literature, specifications, and installation instructions.
- Architectural and structural details of installation for the individual projects, including eave and rake details.
- A sample of the proposed roofing material.
- If skylights are present they must be submitted and reviewed at this time.
- If gutters and downspouts are to be changed, details must be submitted with a sample of the product used.

Application is hereby made to Palos Verdes Homes Association (PVHA) and Art Jury through the office of the PVHA Building Commissioner for the approval of plans in accordance with the description and for the purpose hereinafter set forth. This application is made subject to the following conditions which are hereby agreed to by the undersigned applicant and which shall be deemed conditions entering into the exercise of such approval. **(Copies of this form will be provided upon request).**

That this application does not grant any right or privilege to erect any structure therein described, or any portion thereof, upon any street, alley, or other public place or portion thereof, or upon any portion of lot reserved by restrictions of record for setback or open space or outside of the subject property lines.

That Art Jury approval expires 12 months from the issuance of a building permit by this office. Final inspection is required by the PVHA in addition to any inspections required by the city. Applicant or Owner must contact PVHA for a final inspection upon project completion. Call the PVHA at (310) 373-6721 for final inspection upon completion of construction.
